# Health and Safety!

It has come to our attention that children are coming to and from school on electric scooters. We understand that some children may have received these as recent Xmas gifts but we **CANNOT** allow them on school site.

#### Are electric scooters illegal in the UK?

It is currently illegal in the UK to use a privately owned electric scooter on public roads, pavements or cycle lanes. Electric scooters can only be legally used on private land with the permission of the land-owner. You are, however, legally entitled to buy, sell and own an electric scooter.

In UK law, an electric scooter is classified as a "powered transporter", alongside products such as hoverboards, "go-peds" and powered unicycles.

#### Why is the use of an electric scooter still banned?

The "powered transporter" classification is the reason that electric scooters cannot be legally used on pavements or cycle lanes. Quite simply, motor vehicles cannot be used on pavements or cycle lanes – and in the eyes of the law an electric scooter is a motor vehicle.

Due to the way in which "powered transporters" are designed and motorised, every product in this classification – including electric scooters – falls within the legal definition of a "motor vehicle" in the UK.

Could we also remind all parents that any children arriving at school on a pedal bike or standard scooter MUST be wearing a helmet. Thank you for the support in keeping our children safe.
